The PTO will provide publicity, coffee/tea and a morning snack each day to the crafters, a variety of food that is reasonably priced with waitress/waiter service to your space, a hospitality committee to assist before and during the hours of the show, overnight security, and a very attractive setting for the display of quality crafts. The school building is located adjacent to the heavily traveled Highway 71 where banners will be placed for the benefit of weekend visitors to the area.

Crafters must arrive by 8:00 pm or alternative crafters will be admitted. No set ups on Saturday.

BREAKDOWN needs to be completed by 5:30 pm on Sunday, November 21st.

RULES

All crafts must be original and handcrafted. NO flea market items. Work must be offered for sale. If work violates a craft market rule, it must be removed for the duration of the event.

An exhibitor must attend both Saturday and Sunday for the full duration of the market hours.

ENTRY FEE MUST ACCOMPANY APPLICATION. No refunds will be given after acceptance except for outside spaces in the case of heavy rain for the day that it rains on.

Spaces will be assigned by the Jury Committee to assure that crafts will not be duplicated in an adjacent space. No displays are to extend beyond your assigned area.

Electric outlets (voltage 110) will be furnished per space if requested on the entry form for an additional \$10. Participants will furnish their own heavy duty extension cords. The fire regulations of the Borough will be carefully observed. Overnight security will be provided. Sponsor is not responsible for any loss or injury to the exhibitor or to any assistant or employee in connection with this craft market.

Participants must supply their own tables. All four sides of the display tables must be covered with fabric touching the floor. Please note, this includes the back of the booth area as well. Chairs will be provided. No smoking or alcoholic beverages are permitted in the school. Crafters shall be responsible for any damage or injury that results from collapse of their display.

NO EXHIBITORS WILL BE PERMITTED TO PARK THEIR VEHICLES ON BELL PLACE OR IN THE SCHOOL PARKING LOT DURING THE SHOW. THERE IS AMPLE PARKING ON THE SIDE STREETS.
